SERVICE AGREEMENT

THIS SERVICE AGREEMENT is made and entered into between The Batter's Box, L.L.C., a limited liability company organized and existing under the laws of the State of Missouri, and _____ Applicant's parent who acknowledges and consents to this agreement shall hereinafter be identified as "Parent".

THE PARTIES THEREFORE wish to set forth the terms of their agreement in this Service Agreement. School proposes to provide Applicant certain services including coaching and teaching instruction as it relates to baseball skills including pitching, hitting and catching.

1. **Number of Sessions & Cost.** The Batter's Box shall provide _____ weeks of instruction for _____ at a total cost of _____. There shall be no rescheduling of the sessions by The Batter's Box, LLC except for weather issues or acts of GOD. There shall be no make-up sessions due to Applicant's illness, unavailability or vacation.

2. **Parent's Responsibilities.** Parent agrees to abide by any written rules implemented by The Batter's Box, LLC and handed out with this Service Agreement. FURTHER, PARENT ACKNOWLEDGES AND AGREES THAT THEY CANNOT PARTICIPATE IN THE INSTRUCTION SESSION.

3. **General Release.** Applicant acknowledges that the instruction sessions will occur on The Batter's Box, LLC property. Parent hereby releases and forever discharges The Batter's Box, LLC from any claims related to injuries which may be suffered by Applicant by participating in the instruction sessions. Parent acknowledges that any sporting activity, including baseball instruction clinics, pose a certain health risk to Applicant and waives any claim it may have relating to such potential injuries. Knowing and acknowledging such a health risk to Applicant, Parent assumes the risk and expressly desires that Applicant be allowed to participate in the instruction sessions.

4. **Entire Agreement.** This Service Agreement shall constitute the entire agreement between the parties with respect to the subject matter mentioned herein and no modification, amendment, waiver or alteration shall be binding upon the parties unless in writing signed by both parties. This Service Agreement shall be governed by the laws of the State of Missouri.
